DAY #5

Friday, November 15, 2024
Oklahoma City, OK

Following breakfast, we will travel to Oklahoma City and visit the Oklahoma City National Memorial. The Memorial is comprised of two separate components; the 3.3-acre Outdoor Symbolic Memorial that includes the Gates of Time, which mark the time before and after the bombing took place, and the Field of Empty Chairs, which memorializes each of those killed. Inside the 50,000-square-foot Memorial Museum, interactive exhibits offer a chronological, self-guided experience through the story of April 19, 1995, and the days, weeks, and years that followed. Next, we will check into our hotel, located in the historic "**Brick Town**" district of Oklahoma City. Brick Town, is a lively entertainment district; with repurposed warehouse spaces that are home to restaurants, piano lounges, and chic wine bars. The eclectic mix of shops offers clothing, home décor, and specialty food items like gourmet condiments and handmade chocolates. Enjoy a narrated "**Cruise on the River Walk**" (weather permitting). The remainder of the evening is free to explore the lively entertainment and dine at one of the multitude bistros/restaurants in Brick Town. (B)
