Any surcharges and/or tax increases received from suppliers for this package (Airlines, Cruise Companies, Hotels, etc.) may result in an increase in the per person price of your tour package. - Cancellations received on or before September 15, 2025, will receive a full refund, less a
- \$100 administrative fee
- Cancellations received after September 15, 2025 and prior to September 30, 2025 will be assessed 25% of the per person tour price
- Cancellations received on or after September 30, 2025, and prior to October 1, 2025 will be assessed 50% of the per person tour price
- Cancellations received on or after October 1, 2025 will forfeit the full price of the tour
