**Day #1 Saturday August 9, 2025**

***Dune Buggies – Windmill Island - Holland Tour***

This evening step back in time as we board a **horse drawn carriage** that takes us over the Thunder Bay River and into the woods to see the magnificent elk. Enjoy the scenery, the smell of pine, and the ever-changing face of the Thunder Bay River as the horses make their way through the woods to the beautiful **Elk Antler Log Cabin**. A blazing fire in a massive split stone fireplace welcomes us. This elegant cabin maintains its rustic appearance while providing every amenity.
